TERMS AND CONDTIONS

- 1. Auction will be held as open tender in the form of sealed bids for each vehicle separately.
- 2. Auction/Bids opening will be held for all the above vehicles at GSP Plot No 10/11, Sector B.I Phase -5 Hayatabad, Peshawar, on 13-12-2022 at 1130 hours.
- 3. A Separate bid should be given for each vehicle, submitted in separate envelop(s) and vehicle number be written on the top left corner of the envelope.
- 4. Sealed bids (as per prescribe bid forms) marked as "CONFIDENTIAL" and addressed to Chairman, Auction Committee, Geological Survey of Pakistan Peshawar, along with Pay Order/Bank Draft, in favor of Director, GSP, Peshawar for an amount equal to 10% of bid price (separately for each vehicle), CNIC copy, complete address with phone/cell number, must be submitted on or before 12-12-2022 up to 1030 hours at the aforementioned location of GSP Peshawar.
- 5. Offers not supported by bid security will not be considered, Cross Cheques shall not be accepted.
- 6. Sealed bids will be opened by the Auction Committee in the presence of eligible bidders/authorized representatives of bidders who may choose to attend.
- 7. On acceptance of bid, balance price shall be deposited within three working days otherwise deposited amount (bid security) shall be forfeited.
- 8. In case of filer 10% tax and for non-Filer 15% tax applicable on the winning bid will be levied in addition to his/her bid price.
- 9. Delivery of the vehicle(s) will be given when full payment is received.
- 10. Bid security of offer not accepted, shall be returned within 7 working days after auction.
- 11. Conditional/ Incomplete tender shall not be accepted.
- 12. Rate quoted should be separate vehicle-wise and "excluding" all applicable taxes.
- 13. All kinds of taxes (applicable)/ expenditure for movement of vehicles shall be made by the successful bidder.
- 14. The vehicle(s) shall be handed over to the successful bidder(s) after transfer of ownership from the concerned Excise & Taxation Office. No payment will be made by the Department for transferring deeds of vehicle(s) from Excise & Taxation Office.
- 15. The successful bidder(s) shall lift the vehicle at his /her own expense within fifteen (15) days from the date of possession. Failing to which ground rent @ 0.5% (par day) of the bid price shall be recovered up to a period of 30 days and thereafter the whole amount will be forfeited.
- 16. Bids should be free from cutting/overwriting. The bid amount should be written both in figure as well as in words which must be clear and legible. Failure to do so shall lead to disqualification from the bid.
- 17. Auction committee reserves the right to accept or reject any or all bids and to add withdrawn vehicle before auction.

18. No appeal against auction will be made in any Court of Law.
